### **Ouestion 6:**

As part of Kambi Group Plc., Sports Information Services Limited is a vendor/supplier that provides sports wagering technology and services to more than 40 online skins and on-property sportsbook operators on six continents through its Kambi system. However, Kambi does not handle the patron's sports wagering account, and it does not provide a standalone mobile application or digital platform able to accept wagers on sports events and other events.

## **Question 7:**

As further explained in answer to question 9, Sports Information Services Limited is a business-to-business supplier of online/mobile and retail sports wagering technology and services on an in-house developed software system.

Sports Information Services Limited holds vendor/supplier licenses in several states in the US. These are Arizona, Arkansas, Colorado, Connecticut, Illinois, Louisiana, Maryland, Michigan, Mississippi, New Jersey, New York, Pennsylvania, Tennessee, Virginia, Washington State and West Virginia.

Sports Information Services Limited is also licensed as a vendor in the following US Tribal Jurisdictions:

Kambi also has a presence in Indiana, where the license is held by Kambi Group Plc., and in Iowa, where a vendor/supplier sports wagering license is not required.

#### **Ouestion 9:**

Sports Information Services Limited d.b.a. "Kambi" is a subsidiary of Kambi Group Plc.

Kambi is a business-to-business supplier of online/mobile and retail sports wagering technology and services to licensed sports wagering operators/skins/casinos/mobile applications/digital platforms, built on and delivered through an in-house developed software system. Kambi's sports wagering services include a front-end user interface, odds compiling, customer intelligence and risk management. Kambi does not provide a



standalone mobile application or digital platform to accept wagers on sports events and other events. It does not handle the patron's sports wagering account; that relationship is strictly between the patron and the skin/operator/casino/digital platform/mobile application. Kambi is not responsible for payments and geolocation blocking and does not have visibility or control over the patron's onboarding (registration, KYC, DD, deposit).
