1. IMPACT DESCRIPTION

Though we have had several arrests where the party had visited Plainridge prior, the impact to Foxborough is primarily traffic related, accidents, congestion, disabled and wayard motorists. In addition to the traffic related issues, our staff regularly encounters motorists looking for directions to or headed to the Casino, as we are on many of the arterial routes leading in and out of Plainville.

b) Please identify below the manner in which the funds are proposed to be used. Please provide detailed scope, budget and timetable for the use of funds.

These funds would be utilized to acquire a full size pickup truck, suitable for police use, specifically traffic mitigation. The vehicle would be able to tow a trailer loaded with traffic management equipment, such as barriers, cones, signs, etc, and/or an arrow/sign board. In addition to the price of the truck and up fitting of police equipment, the remaining funds would be used for new updated traffic management materials, such as cones, barriers, and if funding allows a towable sign/arrow board. If approved the funds would be used immediately. Our fleet vendor would build the truck, and any remaining funds would be utilized for updated traffic management equipment, all of which our vendor carries at state bid prices. The estimated cost of the fully equipped vehicle is \$72,467, leaving a budget of \$10,000 for new traffic safety equipment.

Please see attached vehicle estimate, the remaining funds would be utilized to purchase additional traffic safety/mitigation devices, such as cones, barriers, and detour signs.

d) Please describe how the mitigation request will address the impact indicated.

Foxborough hosts several primary egress routes to and from the Casino. In the event of a road closure, or detour we do not have a patrol vehicle that can tow our trailer which houses traffic safety equipment. Additionally over the years the cache of cones and barriers has been depleted to almost nothing. The funds would allow us a vehicle capable of moving equipment and or the trailer to address a variety of issues on the roadways, such as downed power lines, defective traffic signals caused by power outages, crashes, etc. This equipment and vehicle would also be vital in the instance of a critical incident at the Casino, or at one of our major venues (Gillette) which is on the primary egress route to and from the casino (Rte.1).

3. CONNECTION TO GAMING FACILITY

The traffic mitigation equipment and vehicle would be available to our staff to deal with any contingency that may arise, on any of the arterial routes to the Casino through Foxborough. It would also be available to our mutual aid partners in nearby towns, which share many of these arterial routes.
