This grant will fund traffic enforcement and education equipment to mitigate safety concerns caused by increased traffic volume on Route 106 since the opening of Plainridge Park Casino.

2. IMPACT DESCRIPTION/CONNECTION TO GAMING FACILITY

a) Please describe in detail the impact that is attributed to the operation of a gaming facility.

As a result of the Plainridge Park Casino, traffic along Route 106 between Mansfield and Plainville has increased in volume, congestion, and, as a result, there are more traffic collisions and calls for wayward or disabled motorists. Route 106 connects the Town of Plainville with motorists from communities of Bristol and Plymouth counties who prefer to avoid highways or are taking advantage of a more direct route to and from the casino.

b) Please provide documentation, specificity or evidence that gives support for the determination that the operation of the gaming facility caused or is causing the impact (i.e. surveys, data, reports)

Since the opening of Plainridge Park Casino in 2015 our town has seen an increase in traffic violations as well as motor vehicle crashes. The Police Department's crime analyst collected this data from the area of Route 106 and 140, which directly connect the Town of Mansfield to the Town of Plainville and is used as an alternate non-highway route to the casino. The data shows that in the years of 2016-2018 as Plainridge was a brand-new casino location in the state of Massachusetts, the number of violations and crashes had increased. The year of 2014 was the last full year of traffic data collected by our department before the casino opened in June of 2015. In 2014 there was 978 traffic violations and 429 motor vehicle accidents on Route 106. This compares to 2016, the first full year of the casino being operational, where there was 1157 violations and 541 motor vehicle accidents along the same location. That is a 16% increase in traffic violations and a 21% increase in accidents.

In addition to our internal analysis, traffic counts from MassDOT confirm an increase in volume between 2016 through 2018 before decreasing significantly in 2020 due to Covid-19 and the casino not being fully operational throughout the entire pandemic. MassDOT data shows a consistent trend of increased volume from 2014 (11,283 average daily cars) to 2016 (12,259 average daily cars) at the Route 140 intersection (data for all Chauncy St. intersections will be attached to this application). While the numbers of violations and crashes have decreased over the past two years substantially, our department expects that to change as the world starts to get back to normal this year and for years to come.

c) How do you anticipate your proposed remedy will address the identified impact?

The increased traffic volume along this major route has a created a safety concern that the Town aims to mitigate through enforcement, education, and engineering with assistance from this grant and in conjunction with the current redesign of the Chauncy St. portion of Route 106. The goal of this mitigation effort will focus on maximizing use of message boards, placing a visual notification crosswalk signal at a key pedestrian access to the MBTA commuter rail stop, implementation of enforcement efforts concurrent with Implicit Bias and De-escalation Training already approved as part of Mansfield Community Mitigation Reserve Fund award, and improving scene safety along the corridor by adding traffic delineators and markers as barricades for crashes, disabled motorists, or lane closures.

The Town intends to utilize a specifically-outfitted motorcycle and pickup truck to increase a visible police presence along the corridor for the purposes of crime prevention, traffic enforcement, and driver education. Signboards will display messages targeting motorists as dictated by analysis of crash and motor vehicle stop data. For example, as crash data supports speed is a factor in the majority of crashes along the corridor, message boards will be changed to display radar readings and flash to warn drivers of violation speeds. Similarly, crash data indicating red light violations are causing crashes will necessitate messages about attentive driving, more visible police enforcement to deter violators before they enter the intersection, and adjustments to timing on traffic lights to decrease the change of a red-light-runner colliding with a green-light-anticipator. Additionally, the SpeedAlert message board will be used to direct motorists to resources for gambling addiction, as well as our Problem-Oriented Policing Unit and website for further information on assistance available through the Mansfield Police Department.

Funds will be allocated exclusively for the vehicles and related traffic safety equipment, all of which will be purchased through authorized vendors. These purchases will be made immediately upon confirmation of grant approval.

c) Please provide documentation (e.g. - invoices, proposals, estimates, etc.) adequate for the Commission to ensure that the funds will be used for the cost of mitigating the impact from the operation of a gaming establishment.

An itemized spreadsheet is attached (Mansfield Public Safety worksheet) which summarizes recent quotes for all requested equipment (quotes are also attached).

d) Please describe how the mitigation request will address the impact indicated.

Increased traffic congestion along Route 106 has created an unforeseen impact on traffic and pedestrian safety since the casino opened. Equipment purchased with funds awarded through this mitigation request would be applied directly to the area of need.

After receipt of the speed/message board and speed signs, the equipment will immediately be deployed along the route in areas of highest impact as determined by our internal records management system data and citizen complaints. The flashing pedestrian crosswalk notification signs would be installed as soon as they are received after coordinating with our DPW for installation.

After receipt of traffic mitigation truck, trailer, equipment, and motorcycle, a coordinated response between our front-line supervisors, traffic officer, crime analyst, and commanders will be designed in order to address citizen complaints driven by data analysis of crime and safety concerns along the route. As a result, our Department will work toward a common goal of intensive education and traffic enforcement in the impacted area.

The campaign will include:

- Emphasis on data-driven placement and times of enforcement
- Regular command-level review of data from the enforcement and education effort to ensure officers are adhering to non-bias policing practices.
- Signboard displaying not only speed readings, but other traffic-related warnings and reminders, as well as addiction assistance information with links to our Town website and POP unit with our Mental Health Clinician.
- An increased emphasis on contacts and conversations with motorists as COVID restrictions lift. We are designing informational pamphlets that highlight certain laws for which we find frequent violators, important community safety information (e.g. 3G decommissioning, "lock your car" reminders, and addiction resources).

The equipment received from this mitigation request is essential to supporting our effort to embrace increasing traffic volume without increased safety concerns for our community. In addition to proactive steps we take, the equipment in the requested trailer will ensure scene safety during responses for crashes and disabled motorists. e) How will you provide the data for reporting? How will you measure the effectiveness of the proposed project in mitigating impacts?

Regular analysis performed by the Mansfield Police Department Analyst will compare crash and violation data before and after equipment is purchased. The message and speed signs also collect data that can be used to compare volume and violator activity to previous MassDOT assessments and direct resources to proactively monitor areas of concern (by volume or violator data) more precisely, increasing effectiveness of enforcement and education.

Internal activity and effectiveness and timeline of speed and message boards will be analyzed in our RMS system as it is currently for other areas of Town.

The long-term impact of increased traffic volume was not directly anticipated in the Agreement, however, in receipt of the Community Mitigation Reserve Fund Grant, the agreement earmarked \$10,500 annually to support a crime analyst salary who would monitor impacts of the casino. While not directly anticipated, the Agreement did allow for future consideration that an impact may be discovered by the analyst after the initial project was completed.
