

Dear Mayor McGlynn:

Pursuant to 205 CMR 125.01(1)(a)1. of M.G.L. c. 23K, Wynn MA, LLC designated the City of Medford a "surrounding community" in its response to the Massachusetts Gaming Commission's RFA-2 Application for a Category 1 Gaming License, a copy of which was delivered to your office on December 31, 2013.

To obtain a final surrounding community designation, the City of Medford must assent to this designation in writing within ten (10) days of its receipt of the application. Upon receipt of the written assent, the Gaming Commission shall issue a written notice designating the City as a surrounding community to the Wynn Resort in Everett. To confirm the City of Medford's acceptance of this designation, please countersign this letter and return a copy to me and the Massachusetts Gaming Commission on or before January 10, 2014.


The City of Medford is making this request for designation as a "surrounding community" for reasons which include, but are not limited to the following:


